Terms & Conditions

1. Minimum of ½ of the total Pkg price is due at the signing of the Contract and as a retainer for the Wedding Date listed above.
2. All deposits and payments are non-refundable, in the event of a date change or wedding cancellation for any reason.
3. Half of the remaining balance is due 2-week (7 Days) prior to wedding date. The remainder must be received before any photographs will be taken on the day of the wedding.
4. Online-Proof Viewing will be delivered in approximately four to two weeks from the wedding date. High-resolution digital files will be made available by request one year from the wedding date.
5. If Dennise Landgraf is unable to perform to the guidelines of this contract due to fire or other casualty, strike, act of God, act of terrorism or other cause beyond the control of the parties, Picture This by Dennise Photography shall have no further liability with respect to the agreement. If Picture This by Dennise Photography is unable to perform to the obligations in this contract for any other reason, Picture This by Dennise will not be liable for cost in excess of the amount the client has paid. This limitation of liability will also apply in the event that the high-resolution digital files are lost through camera malfunction, damaged in processing, lost in the mail, or otherwise damaged or lost with or without fault of the photographer Dennise Landgraf. While every attempt is made to create the best images possible, no particular photo is guaranteed.

6. In the event of Photographer's illness or other unforeseen circumstances, the photographer Dennise Landgraf may substitute another competent, professional Photographer to take photographs.
7. The client will obtain proofs and high-resolution digital files which may be used for newspaper announcements. Images may be used for personal use only, and may not be sold or published without the written consent of Dennise Landgraf. Photos may not be posted online for sale on commercial photo lab websites such as, but not limited to, Shutterly.com and Snapfish.com.
8. All rights to images created by Dennise Landgraf will remain with the photographer. Dennise Landgraf reserves the right to display any photographs made in conjunction with this wedding as examples of her work for the purpose of window and show room exhibit, advertising, promotion on the internet, publication, instructions and professional competition.
9. Coverage plan times must be used consecutively. Time starts when Dennise Landgraf arrives and the time finishes when the coverage runs out.
10. The client understands that due to the inherent qualities of photographic dyes and materials the photographs may fade or discolor over time. The client agrees to release the photographer Dennise Landgraf from any liability for any claims based whatsoever upon fading or discoloration due to such inherent qualities. If during the wedding ceremony flash photography is not allowed, the client understands that high ISO settings must be used creating a pixilated or grainy effect in the photographs.
12. Photographer is the sole professional photographer allowed to photograph the event. Amateur Photographers may take photos during the event if they do not interfere with the contracted photographer and only after the contracted photographer has finished taking the contracted photographs. If interference happens the contracted photographer will notify the designated family representative on site to handle the situation.
13. Any Changes to the agreement must be in writing and signed by both parties. This Agreement incorporates the entire understanding of the parties and is governed by the laws of the State of Texas.

By Signing of this contract the photographer and the clients agree to all terms & conditions stated in this contract.
